## Actions from last site visit:

 To check what the commitment was for planting provision on/near perimeter ditches. Update: This was for northern perimeter and eastern perimeter. Planting aspects can be removed from actions.

- Details of ancillary plant to be submitted. Update: Can be removed.
- Planting areas to be advised on by AQ. Update: See report below

## **Inspection Results Summary:**

- Site access commissioned and clean with two gates installed and 4 yellow painted blocks placed up side of haul road at entrance point. Post meeting note as to need for these blocks as their positioned behind/alongside raised kerbing?
- Traffic directional sign placed opposite site entrance.
- Pipework leading from ditch opposite weighbridge and then below haul road had potential for blocking up with erosion of material accumulating into base of ditch.
- Weighbridge operational.
- Car parking area clean.
- Alongside plant park up area accommodating machinery; haybales for pollution trapping use; water bower trailer and various accumulation of plant items and pieces of kit/machinery now growing. Similar spread of stored pipework and other items extending over to gate leading to Phase 1.
- SM looking to position stockpile alongside haul road to help better define separation of paved/unpaved areas near to loading location.
- Perimeter bund grass establishing well across site.
- Site walked from Broadfield Farm clockwise.
- Phase 1a water body now drained down; 1b being dug with overburden to be transported to storage; 1c being ready for future working and 1c the temporary storage lagoon.
- Discharge lagoon completed and discharge consent now in place site been exporting mineral since around September.
- Translocated hedgerow line walked and growth of plants continuing. Hedge has been trimmed down. Large amount of fungus growth evident on mulch. Rabbit digging at base of protective fenceline evident but did not look any worse than previous visit.
- Whip planting on north western gap in hedgerow appears not to have succeeded possibly combination of hard ground/plant sizes and watering. Animal tracking through ditch evident. Likely to leave this planting as it is and concentrate elsewhere in site.
- As previously noted, tree planting parcels on north eastern side of site showing more failures particularly the western most parcel. Lines of dead trees may be indicative of compacted ground and existing trees showing crown failure/spinicky growth. SM looking to use augering to break ground and replant.
- Eastern land parcel now grassed with take up appearing over the latest seeded areas. VH advised that recent planting taken place in wood block A. Later Andy Clark in following liaison meeting stated tree planting scheduled in wood block B

before Christmas and Wood block C in spring. Stakes being put into blocks over next few days.

- Lagoon area east of wash plant now created and divided into three separate lagoons. Lagoons filled with water.
- Terex washplant commissioned.
- A number of HGV artics taking delivery site during visit.
