**ESS/23/13/BTE** – Waste management facility for the transfer/bulking of municipal waste. Proposed development includes a waste transfer building; dual weighbridge; weighbridge kiosk; office and staff welfare buildings; firewater holding tank and pump-house; underground surface water retention and pipework; package sewage treatment plant; vehicle wash system; staff parking and associated hard-standing areas; new surface access way; alternative vehicle access; fencing and landscaping; and other associated works

**ESS/28/16/BTE** – Variation of conditions 11 and 12 (noise monitoring) ESS/03/17/BTE – Variation of condition 2 (compliance with submitted details) to allow the overnight parking of associated Heavy Goods Vehicles and trailers

**ESS/02/19/BTE** – Variation of condition 3 (hours) and 22 (throughput) to allow operations to continue to 16:00 hours on Saturday, Sunday and Bank Holidays; take place 07:00-19:30 hours on Saturdays following a Bank Holiday; and 20:00-05:00 hours Friday to Sunday on four occasions a year; and increase of throughput to 105,000tpa. Removal of condition 8 (vehicle movements).

**ESS/14/22/BTE** – Variation of condition 2 (approved details) and 3 (hours) to allow an increase in overnight parking and allow operational hours to begin at 06:00 Monday to Sunday and Bank/Public Holidays.

• Planning permission ESS/14/22/BTE approved (see above permissions).

### Inspection Results Summary:

- No site manager present at time of visit. Informed weighbridge operator of our presence and they allowed an unattended site walk to take place.
- A lot of litter along the eastern boundary caught in the boundary planting.
- Empty bins stored behind main building.
- All vehicles were being unloaded with the roller doors closed using traffic light system.
- Waste within building stored in correct bays and doors free from obstruction.
- Odour suppression scheme working.

### Actions to be taken before next site visit:

• Clear litter along eastern boundary.
