Further to my statement provided on 21st October 2022, I wish to provide a further statement.

I am the strategic lead for THURROCK COUNCIL HIGHWAYS. It is my role to organise the roads to be repaired if they are damaged, assess how the repairs will be completed, organise having highways maintained and repaired. I have worked within this role for 7 years and I am responsible for the management and maintenance of the highway network within GRAYS and THURROCK.

The incident occurred on ST CLEMENTS WAY, GRAYS, ESSEX, on MONDAY 5TH SEPTEMBER 2022, at approximately 1025 hours. ST CLEMENTS WAY is a single carriageway bridge which leads to and from various industrial estates within GRAYS. The bridge also leads over live train tracks that connect to LONDON. Over the recent months the road has been a site for several JUST STOP OIL protests, the most recent of which was when JUST STOP OIL PROTESTORS dug a tunnel beneath the road surface, into the structure of the bridge.

On MONDAY 5TH SEPTEMBER 2022, at approximately 1000 hours, I was asked to attend ST CLEMENTS WAY in order to assess the tunnel and the road structure and to form a plan as to how to proceed with repairing the damage in a cost effective and efficient manner. Between the 23RD AUGUST 2022 and 4TH SEPTEMBER 2022, JUST STOP OIL PROTESTORS had dug a hole in the embankment and into the bridge, beneath the road surface of ST CLEMENTS WAY.

The PROTESTORS They had since been removed from the tunnel and I was asked to assess the damage. I arrived on site at approximately 1025 hours, and began assessing the tunnel. The protestors had created a small hole in the road surface in order to keep the road closed whilst their protest was ongoing. In order to fully assess and repair the hole, we had to make this hole bigger. There was the concern that as the tunnel went down and then veered off at 90 degrees, there was a living area that the PROTESTORS had formed and had been staying, which wouldn't fill fully if we were to pour concrete into the tunnel as an air bubble may form. We needed to get the road open as soon as possible as it had been closed for almost 2 weeks by this point. We managed to get a camera down the tunnel to assess the full depth of it and whether the concrete would fill the tunnel sufficiently. The living area the PROTESTORS had made was to the left of the tunnel and was more into the embankment, not directly under the road surface. I determined that filling the tunnel with concrete should be sufficient to repair the damage and the tunnel was later filled with concrete, however there is still uncertainty as to whether it was fully filled. I proceeded to take images of the tunnel before the repairs, which show the damage to the tunnel and the road surface.

I was on site for approximately an hour and half, and left at approximately 1200 hours.

When the bridge was built many years ago, the cost effective method at the time was to build the structure up and infill it with polystyrene blocks. When the protestors dug into the bridge, they dug down into the embankment and into the polystyrene. Whilst the road itself is secure, the protestors removed quite a lot of the polystyrene, however there is still a lot within the structure that remains.

To repair the bridge itself, cost £8282, which is included in the figure of £20,520.81 I previously provided and is shown within the breakdown of costs I previously exhibited as PGW/01. The £8282 covers the back fill and reinstatement, it does not cover earlier vegetation clearances and highways attendances.
