Thank you for your interest in the **Greater Essex Business Board (GEBB)** – a new strategic advisory board of business influencers brought together to advise, advocate, and lobby in the interests of Greater Essex.

# The role and purpose of the GEBB

The GEBB will be a strategic advisory board of business influencers – **advising**, **advocating**, **and lobbying** in the interests of Greater Essex. It will bring together 10-15 influential and inspiring businesses, reflecting key sectors of the economy and geographical areas of Greater Essex. Board members will work closely with officers from local authorities as well as existing regional and local networks, groups and forums to:

#### Influence decisions

The Greater Essex Business Board (GEBB) exists to **influence** economic growth policies at both the local and national level.

GEBB will provide **strategic advice** to political decision-makers. It will have the **freedom and autonomy** to set its own agenda, using evidence to develop, its own positions on key issues.

Its advice will help in setting the strategic direction for local economic policy, including producing and updating an Economic Strategy for Greater Essex.

#### **Advocate for business**

The GEBB will provide the authoritative and authentic **voice of business** in Greater Essex, with the confidence to speak and be heard.

The GEBB will develop **robust mechanisms to engage** with businesses across Greater Essex, listening, gathering intelligence and using this as a basis to inform its work with decision-makers.

The GEBB will develop **connections**, with local, regional and national business networks. It will champion Greater Essex – helping it to stand out and compete.

## **Deliver Impact**

The GEBB will oversee activities that support Greater Essex business, including Growth Hub business support and skills programmes (with Essex Chamber of Commerce).

The GEBB will focus its attention on securing new investment in Greater Essex, supporting and advocating for

- key growth sectors,
- key sites;
- vital infrastructure;
- workforce skills







## **GEBB** priorities

We would expect that, within its first year of operation, the GEBB's priorities will include:

- **Developing a new co-owned Economic Strategy providing advice and guidance on the economic strategy for Greater Essex**
- Playing a **key role** in future negotiations with Government on a renewed approach to Private/Public sector partnership;
- Getting the wider businesses community engaged as Ambassadors promoting Greater Essex, attracting private investors and helping to secure investments in growth-enabling infrastructure
- Establishing appropriate mechanisms for **delivery of government programmes** such as business support activities
- **Identify routes to unlock improvements in growth and productivity**, ensuring the benefits are distributed across all communities in Greater Essex, including through links with the LSIP to influence training and skills provision.







# How the GEBB will operate

The GEBB will be chaired by a recognised business leader. It will have appropriate administrative and financial support to undertake its work. It will It will operate through working groups with expert support to follow-up on the direction set by the Board. The GEBB's success will lie in its ability to convene partnerships, influence policy and to attract investment to Greater Essex.

#### The GEBB will...

...convene business interests from across Greater Essex, the UK and across the globe to gain the best insight into local challenges and potential solutions.

...focus on outcomes and the action required to deliver them, rather than on formal meetings, process and paperwork.

...work in the open promoting transparency in to work to build support and momentum from across Greater Essex business.

...partner with those who have shared interests and can help influence decisions to the benefit of Essex businesses – whoever and wherever they may be.

## The GEBB will not...

...work to an agenda constrained by local councils

...simply rubber-stamp decisions that have already been taken;

...have lots of board meetings and spend time just receiving information ...duplicate the work of existing local business groups

...waste time and energy on issues where it cannot and secure impact;

....shy away from delivering difficult messages to those in power

...increase bureaucracy or act as a gatekeeper; or

...act in isolation.







## Important information

#### We envisage that:

- 1. the board will come together around key activities and meet approximately four times a year;
- 2. the first GEBB meeting will take place in December 2024;
- 3. board members will act as ambassadors for Greater Essex Business. They will act in the interests of the business community and be active in promoting the voice of business from across the area;
- 4. board members will draw upon their national, international, business and government connections to advance the interests of Greater Essex;
- 5. board members will engage widely, gathering intelligence from the local business community, and sharing this with elected leaders and policy-makers to inform investment priorities and growth enabling policies; and
- 6. appointments to the Board will be made for a 1-year term in the first instance, allowing for flexibility and to reflect the changing local political and economic environment. This is a non-remunerated role.







## Person specification – Board Member

We are seeking inspirational business leaders to provide the voice of business. As a Greater Essex Business Board member, you will:

- Share your perspective, expertise and experience to influence policy
- stimulate economic growth, productivity and competitiveness
- provide advice on the economy and local business landscape
- adopt a strategic role, rather than pursuing the interest of your individual sector

#### We are looking for members who:

- are influential and inspirational businesspeople with executive experience in business at a senior level or have experience in alternative entrepreneurial leadership roles;
- have an understanding of, and a commitment towards, the growth, productivity and prosperity of the Greater Essex economy;
- bring an exceptional knowledge and can act as ambassadors of their sector;
- are passionate about improving the region and promoting it to national/international audiences, supporting investment activity;

- are independent thinkers and can provide specialist, businessled insights to critically influence, shape and review economic development activity in Greater Essex;
- are passionate about the Greater Essex regional economy and can act as advocates for the area and the opportunities offered for growth;
- can demonstrate an inclusive, open and collaborative approach;
- can work together to address challenges and opportunities,
   which will deliver transformative change for the Greater Essex economy







## Wider characteristics – Board Member

#### Board members should:

- be committed to promoting equality, diversity and ethical business practices and be environmentally considerate
- be willing, committed and prepared to positively collaborate
- bring their own **experience**, **expertise** and **insight** to bear (as opposed to pursuing individual and/or organisational interests) to ensure **actions** are **delivered**
- adhere to **high standards of behaviour** and not bring the business board into disrepute adhering to the Nolan Standards in Public Life and wider Board policies
- be responsible and professional in their communications regarding their work on the Board (including social media and/or speaking opportunities)
- maintain strict confidentiality and privacy regarding any commercially sensitive content
- be respectful of others' views
