1 Introduction

1.1 Background

Essex County Council commissioned the Strategic Environmental Assessment Team of Essex County Council's Spatial Planning Group to undertake a Sustainability Appraisal, incorporating Strategic Environmental Assessment, on the proposed Replacement Mineral Local Plan: Pre-Submission Draft.

The Strategic Environmental Assessment Team are acting as consultants for this work, therefore the content of the Sustainability Appraisal should not be interpreted or otherwise represented as the formal view of Essex County Council.

This document is Annex H to the Environmental Report which sets out the Quality Assurance Checklist for the SA/SEA Environmental Report.

1.2 Quality Assurance Checklist

A quality assurance checklist is an important tool which allows the Sustainability Appraisal incorporating the Strategic Environmental Assessment (SA/SEA) to be reviewed to ensure that the requirements of the SEA Directive¹ have been met. It also shows how effectively the appraisal has integrated sustainability considerations into the plan making process.
